EXPENSES INCLUDE POSTAGE, STATIONERY, BURMAN NEWS PRINTING, MAILING, BOOK PURCHASES, ETC. WE BOUGHT AND SOLD 110 COPIES OF SPEARHEAD ALONE. THIS ITEM COST US \$1,354.12. WE MADE MONEY ON THE SALES. WE SENT OUT 732 PIECES OF MAIL WHICH COST US \$2,165.52. + 6833 COPIES OF THE B/N INCOME THIS YEAR FROM DONATIONS AND SALES =\$13,590.22

BALANCE IN EXEC SEC ACCT LAST YEAR (\$-92.19). THIS YEAR \$4,096.38

WHEN THE MEMBERS REALIZED THAT THE EXEC SEC HAD GONE INTO A DEFICIT LAST YEAR, THE DONATIONS INCREASED DRAMATICALLY. APPARENTLY THEY WERE PROVIDING MONEY TO PRINT THE DIRECTORIES EVERY YEAR. THIS PAST YEAR WE RECEIVED ONE DONATION OF A THOUSAND DOLLARS AND SEVERAL OF \$500. MANY PEOPLE DOUBLED THEIR DONATION.

IT SHOULD BE NOTED THAT THE DIRECTORIES COST US ABOUT \$3 EACH AND THE MEMBERSHIP

DONATIONS AVERAGE OVER \$20 EACH. THE COST OF THE DIRECTORIES IS UNDERWRITTEN BY THE MEMBERSHIP. WE RECEIVED 221 DONATION CHECKS THIS PAST YEAR AT HOME AS AGAINST THE DONATIONS RECEIVED AT THE REUNIONS. THE DONATION TOTALS DURING THE YEAR WOULD APPROXIMATE \$4420 AS APPLIED AGAINST THE COST OF DIRECTORIES OF \$900. THE BOARD OF DIRECTORS APPROVED MOTIONS TO PRINT THE DIRECTORY EVERY YEAR AND ALSO TO MAIL OUT A COPY TO THE FOLKS AT THIS YEAR'S REUNION.

To David Richardson for finding the Hotel and to Ferd Stauch for setting up the sightseeing tour, that was enjoyed by many of our Marauders and their families. Thanks to our Friday banquet speaker, Grant Hirabayashi and to Col. William Ivey, our Saturday Banquet speaker. Special thanks to the Second Generation Marauders, for the splendid way they filled the voids. Susie Weston who hosted the Ladies Tea. Linda Burchett and Mark and Sherry Cowling, for their very touching memorial service, Richard Avery who made himself indispensable, my right hand man John Passanisi and to the many unnamed others.

For those that are not aware; the Second Generation Marauders are our descendants that desire to take part in our association, there aren't any other requirements to becoming a Second Generation Member.

We were honored to have Mr. Zia-lian Tao, one of the Chinese Infantry Soldiers that fought in Burma along with us, attend the reunion. Mr. Zia-lian Tao came all the way from China, to exchange banners with Merrill's Marauders at the

Saturday Banquet.

Our website attracted the attention of Wayne Gray and Mike Vincenti, with Digital Ranch, Producers of Dangerous Missions for the History Channel. They attended our reunion and interviewed Marauders for the Merrill's Marauders show they are producing. Also attending was the writer of a current best-seller about World War II (In Harms Way, about the sinking of the USS Indianapolis) Doug Stanton. Mr. Stanton is investigating the possibility of writing a book on the Marauders.

To all that attended; thank you for coming, to all that didn't; we dearly missed you and hope to see you at Valley Forge.

Note: For those that stayed on, at the Marriott Sunday night; check your bill and make sure you were charged \$79 plus tax for Sunday night and not \$165. The hotel has erred in a few cases.

NEW BUSINESS – Mike Mc Laughlin tendered his resignation as Vice President, saying press of business as a lawyer in Alaska prevented his giving sufficient time to Association. His resignation was accepted with regret, and with applause for his valued services to the Association.

ELECTION OF OFFICERS:

Reunion chairman Bob Passanisi said that Phil Piazza had resigned as Association President following the year 2000 reunion, but later agreed to accept the office on a new and less burdensome basis as President Emeritus. The question of duties of President vs. President Emeritus was discussed and it appeared that it was important that Piazza had to be an elected officer in order to continue his duties as the Association's liaison with the Rangers

This calls for him to continue his all-important duties representing the Marauders with the Ranger community but to leave other responsibilities to other Association officers, such as the developing of reunion sites and Hall of Fame nominations. The point was made that an association officer bearing the word "emeritus" after his title could no longer hold an active roll, as he would be required to in matters at Fort Benning. The debate ended with the nomination of Piazza to continue as President – dropping the emeritus title so as to actively carry out the newly defined liaison duties. A motion to this effect was seconded and passed.

Chairman Passanisi said that in view of this development, the Board called off its earlier request for members to nominate others for President. Members had nominated Jackson Pokress but they withdrew his name, making Piazza's election unanimous. The word that Piazza would continue as President was welcomed with a show of support.

Jack Pokress supporters then entered him in a race for the Vice-Presidency, vacated by Mike Mc Laughlin because of the press of legal business in Alaska. Charles Ketcham was also a candidate. Pokress was elected Vice President. All other Association officers were re-elected by simple voice vote.

REUNION SITE: AFTER 26 YEARS - VALLEY FORGE IN 2002

It was announced that the Executive Committee, made up of all Association Officers, had decided to recommend holding next year's annual reunion in the East, following reunions the last two years in the South and Midwest. In the absence of any firm site proposals from other Association members, the Board submitted two hotels in Pennsylvania, for consideration by the General Business Meeting. Details were provided for each regarding package rates, facilities, transportation, etc. The winner in the voting by a clear margin was the Hilton Valley Forge in King of Prussia, near Philadelphia. The other proposal was the Westin Convention Center in Pittsburgh.

The reunion site for Merrill's Marauders Association on August 30-31, 2002, will be the Hilton Valley Forge, in the Philadelphia suburb of King of Prussia. The Association last held a reunion in King of Prussia in 1976, at the Holiday Inn.

The Hilton Valley Forge won a majority of votes of members attending the business meeting at the Indianapolis reunion, beating out the Westin Convention Center in Pittsburgh. It won out over the Pittsburgh site with a package rate per couple of only \$306 -- \$24 less than this year. A recent survey of our membership in the Burman News showed more members of the Association still come from Pennsylvania than from any other State

The two-day all-inclusive package rates offered by the Hilton Valley Forge were slightly lower than those of the Pittsburgh Westin, at \$306 for a double room, \$236 for a single and \$69 plus tax for extra nights, compared with the Westin's \$307, \$238 and \$72. But the deciding factor was the wider variety of historic and other attractions in the surrounding Valley Forge area. That site was chosen by an overwhelming vote of members attending the Indianapolis reunion.

Further details about the Hilton Valley Forge reunion will appear in coming issues of the Burman News.

LIAISON OFFICER -- Dave Richardson

A few months ago in Ft Benning, another Marauder was inducted into the Ranger Hall of Fame. He is Ted Mc Logan, who served with the Second Battalion's Green Combat Team.

We can all take pride in the fact that Ted is the 17th member of Merrill's Marauders to be inducted into this Hall of Fame in its nine years of existence. I don't believe any other Ranger outfit can match that record -- at least in the category of gallantry in action. Phil Piazza deserves a lot of credit for keeping our nominations flowing over those years.

So far this year, we have come up with one nomination for the 2002 Ranger Hall of Fame. He is Bob Carr. The Board has gone over his qualifications and endorsed him, in accord with our Bylaws. Bob's big moment came at Nhpum Ga, when as a lead scout in the Third Battalion; he

volunteered to serve as forward artillery observer. He first dragged two wounded Marauders to the medics under heavy fire, then crawled to within 30 yards of a Japanese machine gun nest and directed the shelling that blasted the enemy off a commanding hill and forced their retreat. This opened the way for the freeing of the Second Battalion which had been trapped by the enemy for two weeks.

There are still a couple of months left in which we can submit other nominations for the Hall of Fame. As always, anyone can submit a name for consideration. We have prepared a memo on just how to do so, available from me. Each Ranger Association unit is permitted to send in up to three names for consideration by the Selection Board at Ft Benning. That gives a possible total of 18 to choose amongst. The Selection Board usually chooses about 12 a year. But in the last three years, our Association has managed to come up with less than half our permitted number because so few send in a name.

So our Board urges you to look around again and see who else you feel may be a good choice – for showing either extraordinary valor in combat or exceptionally meritorious service to the cause in peacetime. A Marauder who has either died in the war or since is also eligible. Plan on doing the same thing in years to come to keep our nominees flowing.

Later in that meeting, you were asked as usual to vote for a Reunion site for next year. You may remember that we have changed the process of selecting sites in the last couple of years. Now we ask that anybody who wants to suggest a given hotel must submit a proposal for that site by mid-July so that a member of the Board can investigate first-hand to be sure it meets all of our very detailed requirements. The Board takes it from there, selecting one or more sites on its own, if necessary. So you are assured before you vote that the hotels meet all of our criteria.

Thanks for asking about my Father, Gustave R Adams. His experiences in World War II were never discussed at home. He always avoided any questions about the war. Our family (us kids) did not know until he passed away that he had earned the Purple Heart and other Medals. He had never asked for them. I wrote to the Defense Department and they were kind enough to forward our request to the National Archives and they mailed the Medals to us. In the letter they sent to us, they also mentioned that they did not have any of his personnel records, as they had been in a building that had been destroyed by a fire. My Brothers were so excited when we received the Medals. My Father Gustave R Adams died October 5th, 1991 on his 75th birthday. My Mother and Dad lived at 2035 English St, Maplewood MN 55109. 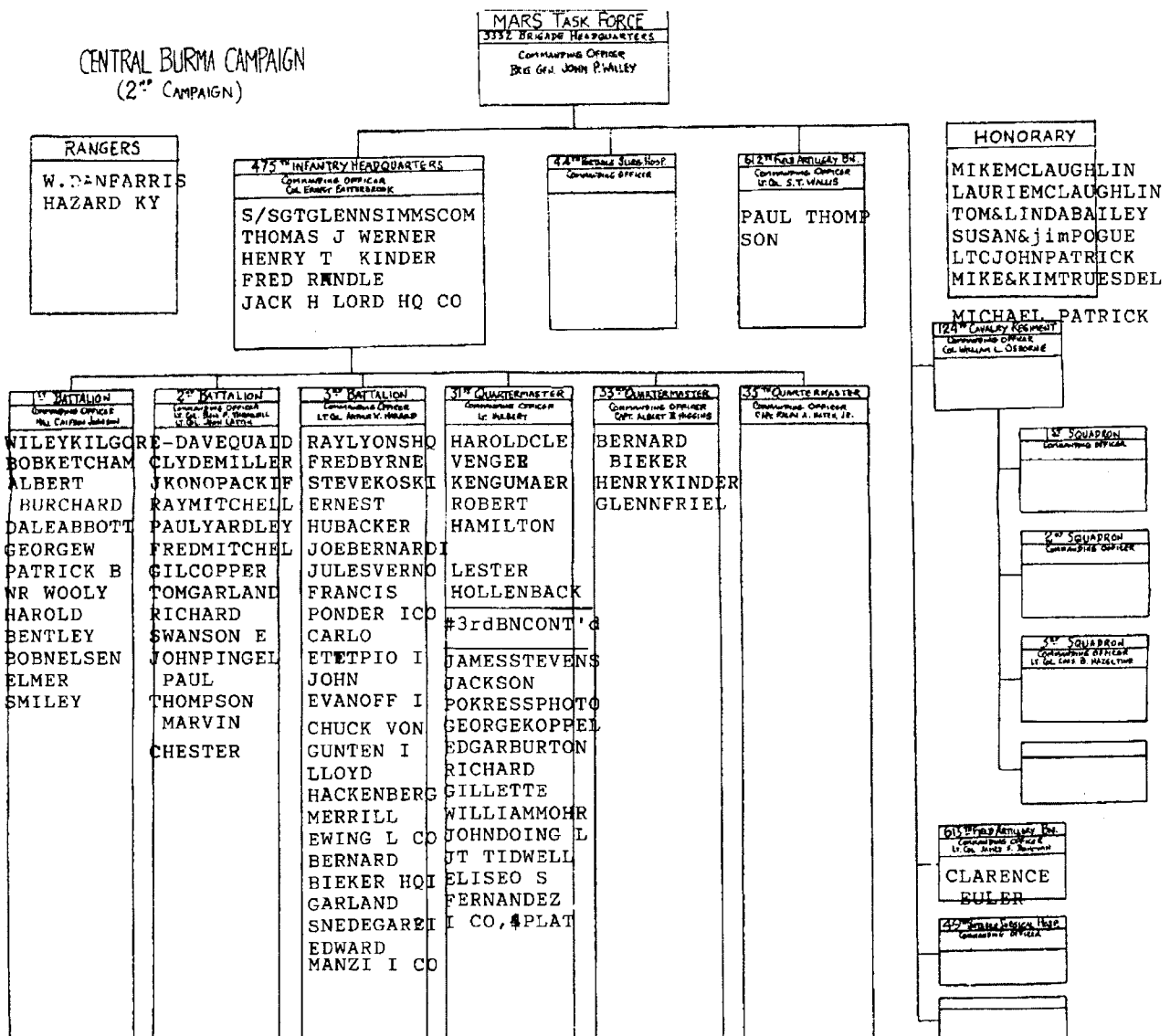

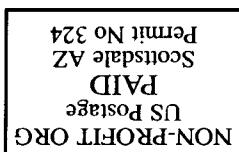
